COOKIES POLICY

A. Introduction

Our Website uses cookies for its proper operation as well as the best experience of its visitors.

B. What are Cookies?

Cookies are small text files containing a string of characters that can be placed on your computer or device that uniquely identify your browser and / or device. The information used by browsers (browsers) (Chrome, Mozilla Firefox, etc.) can help to improve the functioning of the Website enabling it to recognize the user's preferences each time the user returns.

Other technologies, including the data we store on your browser or device, the information associated with your device, and other software, are used for similar purposes.

Our Website does not request personal information from its visitors while navigating its content. Our Website collects personal information of its visitors / users only when they voluntarily provide it. Personal information is the data that can be used to identify or communicate with an individual, as well as other information relating to that person. Therefore, the information we collect from you or about you differs depending on the Service you choose to use through our Website.

C. Cookies Types

There are generally four categories of cookies, "visit cookies", "permanent cookies", "first party cookies", and "third-party" cookies. Our Company also uses all four types of cookies.

• Session cookies

These are temporary cookies that remain in the cookie file of your device's browser only during your visit and are deleted when you close the browser.

• Permanent cookies (persistent cookies)

Those cookies remain on your browser even after the browser closes, sometimes for one year or more (the exact length of stay depends on the lifetime of each cookie). Permanent cookies are used when the site administrator may need to know who you are for more than one visit (e.g., remembering your username or your site configuration preferences).

- **First-party cookies**

These are cookies installed on the browser and / or hard drive of your device from the site you are visiting. This includes assigning a unique identifier to you to monitor your site navigation. Website administrators often use first-party cookies to manage visits and for identification purposes.

- **Third-party cookies**

These are cookies used by third parties, such as social networks to track your visits to the various sites they advertise. The site administrator has no control over these third-party cookies.

Q. How long will the cookies stay on my device?

For how long a cookie will remain on your computer or on a mobile device depends on whether it is a persistent cookie or a session cookie. Session cookies will remain on your device only until you stop browsing. Permanent cookies remain on your computer or mobile device until they expire or are deleted.

E. Services and Third-Party Tools

Service providers may use cookies and these cookies may be stored on your computer when you visit our site.

We use Google Analytics to analyze the use of our site. Google Analytics collects information about the use of the site through cookies. The information collected about our site is used to generate reports about the use of our site. Google's privacy policy is available at <https://www.google.com/policies/privacy/>.

We use Tawk.to for website live chat service on our site. This service uses cookies to create session only while you are browsing on our site. You can view this service provider's privacy policy at <https://www.tawk.to/legal/>.

F. Collection of Information

The information that we collect is used to communicate with you about our Services and to inform you about our policies and terms and to respond to you when you contact us.

G. Cookies we use

We use Cookies for the following purposes:

1. Situation

We use cookies to see if you are logged in to our site.

2. Personalization

We use cookies to store information about your preferences and tailor our Website for you.

3. Advertising

We use cookies to help us run ads of interest to you.

4. Analysis

We use cookies to help us analyze the use and performance of our Website and Services.

5. Identity Control and Security Promotion

We use the information available to us to verify accounts and activities and to promote security, whether within or outside the Services, by investigating, for example, suspicious activity or violations of our terms or policies.

6. Cookie consent

We use cookies to store your preferences in relation to the use of cookies in general.

Q. How do I manage or delete information about me?

The data is stored for as long as necessary to provide services to you and other users, including those described above. The information related to you will remain stored until you request for deletion.

I. Manage Cookies

The installation of "cookies" is only allowed with the consent of the visitor / user and after appropriate updating.

The user can modify the browser settings to block some or all the cookies. Most browsers allow you to deny cookies and delete cookies. Methods for this purpose differ from the browser and the version in the release. However, you can get up-to-date information about blocking and deleting cookies through these links:
